Subject: Home and Community Based Services Policy revisions to reflect implementation of the
Fiscal Year 2019 Budget

Renewal of Home and Community Based Services (HCBS) Aged and Disabled Waiver

Effective July 1, 2018, the average statewide monthly cost for nursing facility care shall decrease to
\$3207.13. For participants restricted to 60% of the monthly cost maximum, the amount shall decrease
to \$ 1924.27.

With the cost cap decreasing and the unit rates increasing Person Centered Care Plans (PCCP) will need
to be adjusted accordingly at the time of the reassessment, or at the time that a care plan change is being
made.

Additionally, Home and Community Based Services Units Rates 3.00 Appendix 1 and Home and
Community Based Cost Maximums Appendix 2 have been revised to reflect the updated service unit
rates and monthly unit maximums.

The following policies have been revised to reflect these changes:
